NOTES ON FEES

- The PNG UNRE Council has approved an increase in the 2024 fees by 7 percent (%) to accommodate the increases in prices of goods and services. The effect of this increase on the fees, is minimal.
- The sub-total of Compulsory Fees together with outstanding fees owing by continuing students must be paid in full before the 6th March, 2024.
- If you need accommodation on campus, you must also pay the required Board & Lodging (B&L) Fees; however, those unable to pay full B&L fees, must pay fifty (50%) percent of B&L fees before the 6th March, 2024, with the remaining balance to be paid by the 28th June, 2024.
- All Fees must be paid into the PNG University of Natural Resources & Environment's Bank Account # 1000-688625 with Bank South Pacific, Kokopo Branch.
- You must ensure that the deposit slip clearly shows the student's name and the university Bank Account number & check to ensure the Bank Teller inputs the student's name to appear on the bank statement. The deposit slip must be presented at the University's Accounts Section for an Official Receipt to be issued.
- Non-payment of the required fees by the given deadline will deny completion of your registration formalities.

- 7 The fee for Repairs & Maintenance is to cover for possible losses or damages to university property. It costs the University more for the damages to University Property by students.
- 8 Fees payable by a student on TESAS Scholarship may be adjusted subject to advice from the Department of Higher Education, Research, Science, & Technology (DHERST). In the event that DHERST does not pay for its component of the fees, the student will be responsible to pay up the fees.
- 9 The university does not accept "Letters of Guarantee" as a means for a student to register. All fees must be paid in full by the 6th March, 2024.
- 10 Any student who is not able to pay all applicable fees as stated above, must not come to PNG UNRE for studies in 2024. The University will not be responsible for the welfare of any student who turns up without paying the required fees, and is denied Registration and Board & Lodging facilities on campus.

SOME IMPORTANT DATES

1. Registered 2023 Students begin to arrive on the 2nd January, 2024, to complete the suspended 2023 academic year (Vudal Campus ONLY).
2. New Students & Re-enrolling students begin to arrive at both Vudal & Popondetta campuses, on the 6th March, 2024.
3. Orientation for the new students will run from the 11th March, 2024 to the 15th March, 2024.
4. Registration for all students will be conducted as students arrive and will close on the 15th March, 2024.
5. Lectures for all students for the 2024 Academic Year will begin on the 18th March, 2024.
6. Late registration will be conducted on the 28th March, 2024 only. Students will be required to pay a Late Registration fee of K50 in order to register late or be denied registration.
